### POSSESSION NOTICE

Whereas

The undersigned is the Authorised Officer of Asset Reconstruction Company (India) Limited acting in its capacity as trustee of Arcil-CPS-002-IX Trust (hereinafter referred to as "**Arcil**"). Arcil has issued notice under Section 13 (2) of Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002 (hereinafter referred to as "SARFAESI Act") to **M/s Shamken Spinners Ltd.** (hereinafter referred to as "the Borrower") on **May 26, 2006** in respect of the financial assistance granted to the Borrower by ICICI Bank limited ("ICICI") (All rights, title and interest of ICICI in respect of the said financial assistances including all the underlying security interest since assigned to Arcil), calling upon the Borrower to repay the aggregate amount mentioned in the Demand Notice being **Rs.85,08,03,982.00 (Rupees Eighty Five Crore Eight Lakh Three Thousand Nine Hundred and Eighty Two Only)** to Arcil as of April 30, 2006 together with further interest thereon, within 60 days from the date of the said notice.

The Borrower having failed to repay the said amount, notice is hereby given to the Borrower and the public in general that the undersigned has taken possession of the properties described herein below in exercise of powers conferred on him under Sections 13 (12) and 13(4) of the said SARFAESI Act read with rules 8 and 9 of the said Rules on this **23<sup>rd</sup> day of December of the year 2010.**

The Borrower in particular and the public in general is hereby cautioned not to deal with the property and any dealings with property will be subject to inter alia the charge of Arcil for the said amount of a **Rs.85,08,03,982.00 (Rupees Eighty Five Crore Eight Lakh Three Thousand Nine Hundred and Eighty Two Only)** to Arcil as of April 30, 2006 together with future interest at contractual rate on the aforesaid amount and incidental expenses, costs, charges etc. incurred / to be incurred from May 01, 2006 onward until the date of payment.
