

Doctor stabbed by patient's son at Chennai hospital

AN ONCOLOGIST was injured after he was stabbed multiple times, allegedly by a patient's relative, at a government hospital in Guindy, Chennai, on Wednesday.

The attack at the Kalaignar Centenary Super Speciality Hospital (KCSSH) triggered strong reactions and protests from medical professionals over safety and staffing conditions in government hospitals.

Police said Dr Balaji Jagannath, who is in his late 40s, was on duty in the hospital's oncology department when he was approached by the accused, Vignesh, 26, a resident of Perungalathur. According to police, Vignesh entered the hospital at around 10.30 am to meet his mother, a cancer patient undergoing treatment there. He was accompanied by three friends. Once inside, the group allegedly engaged in a heated dispute with Dr Jagannath over the woman's deteriorating condition, with Vignesh accusing the doctor of

negligence. According to the police, Vignesh attacked the doctor with a kitchen knife, stabbing him in the neck and also inflicting injuries on his head and upper body. Onlookers quickly intervened and escorted the doctor to the ICU. Hospital sources said the doctor, a cardiac patient who underwent a major surgery sometime ago, is stable and under observation.

Hospital staff, along with bystanders, apprehended the accused, who is now in police custody along with four others

detained for further inquiry, authorities said.

Tamil Nadu Chief Minister M K Stalin called the attack "shocking" and assured that "necessary treatment" would be provided to the injured doctor. He also ordered a "detailed inquiry" into the circumstances surrounding the incident and emphasised the government's duty to protect medical professionals.

Meanwhile, doctors' bodies demanded immediate action from the state government to address critical staffing shortages.

Rajasthan Congress rebel 'slaps' SDM during bypolls

CONGRESS REBEL Naresh Meena, who is contesting the as-

sembly bypolls as an independent candidate, allegedly slapped Malpura sub-divisional magistrate Amit Choudhary at a polling station in Deoli subdivision Wednesday.

The purported incident was captured on camera and has since gone viral. The viral video purportedly shows Meena, who is contesting the election from Deoli-Uniara, forcing his way into

a polling booth in Samravata village despite resistance from the police standing guard outside. When he comes out minutes later, he purportedly heads towards the SDM and slaps him.
